A RESOLUTION AND PROCLAMATION OF THE SALT LAKE COUNTY COUNCIL TO RECOGNIZE Brittany Grimes, Richard Brockmyer, Katrena Freeman, Jeremy Goldsmith and Glenn Hammer for outstanding service to the taxpayers of Salt Lake County.

WHEREAS, the goal of Salt Lake County is to provide outstanding local government services at an affordable price, and

WHEREAS, Salt Lake County has experienced enormous growth in the past decades, leading to some confusion over which businesses reside in which jurisdictions, and

WHEREAS, Brittany Grimes, Richard Brockmyer, Katrena Freeman, Jeremy Goldsmith and Glenn Hammer, working under four different supervisors, stuck together as a team to solve and invent a solution for the very difficult task of verifying business license coding, and

WHEREAS, on her own initiative, Brittany Grimes of the Salt Lake County Business Licensing in Planning and Development Services and staff began reviewing the Utah State Tax Commission data file for business licensing to determine if businesses in the unincorporated Salt Lake County were coded correctly, and thus, the appropriate sales tax was coming to the County, and

WHEREAS, Brittany and her team discovered 468 businesses located in unincorporated Salt Lake County that were coded to other cities, and

WHEREAS, after gently reasoning with the Utah State Tax Commission to get these location codes corrected, the Tax Commission will redistribute the Sales Tax revenue for the 90 days prior to the request, and

WHEREAS, this means more than \$100,000 of sales tax returning to the County, generating up to \$400,000 annually in the future.

NOW THEREFORE, BE IT RESOLVED, by the Salt Lake County Council, to honor Brittany Grimes and her team for their exceptional work, dedication and initiative.
